
EAST



DESCRIPTION

COMMENCE at the Northwest corner of the Southwest 1/4 of the Southeast 1/4 of Section 20, Township 4 South, Range 17 East, Columbia County, Florida and run S. 01° 22'17"E. along the West line of said Southwest 1/4 of the Southeast 1/4 a distance of 250.00 feet to the POINT OF BEGINNING; thence N. 88°33'37"E 377.37 feet; thence S. 00°15'54"W. 380.17 feet; thence S. 88°33'37"W. 342.00 feet to a point on said West line of the Southwest 1/4 of the Southeast 1/4; thence continue 5.88°33'37"W. 40.04 feet to a point on the Easterly Right-of-Way line of County Road No. 131; thence N. 00°58'13"E, along said Easterly Right-of-Way line 360.09 feet to the Point of Curve of a curve concave to the West having a radius of 22958.31 feet and a central angle of 00°03'01", said curve also having a Chord Bearing of N.00°56'42"E. and a Chord Distance of 20.26 feet; thence Northerly along the arc of said curve (being also said Easterly Right-of-Way line of County Road No. 131) a distance of 20. 26 feet; thence N. 88°33'37"E. 24.51 feet to the POINT OF BEGINNING. Containing 3.31 acres, more or less.
