COMMENCE AT THE NORTHEAST CORNER OF THE

INTERSECTS THE SOUTH DIVISION LINE OF THE COLUMBIA  
COUNTY SURVEY, FORTY FEET SOUTH OF THE LINE OF BRADLEY STREET,  
FOURTY FEET FROM THE DOMINIQUE BAPTISTE AND JAMES STREET,  
S. 87-45' W. ALONG THE SOUTH LINE OF PUTNAM STREET  
214.3 FEET THENCE S. 65-50' E. 165 FEET THENCE  
45-45' E. 165 FEET TO THE EAST LINE OF DAKE AV.


