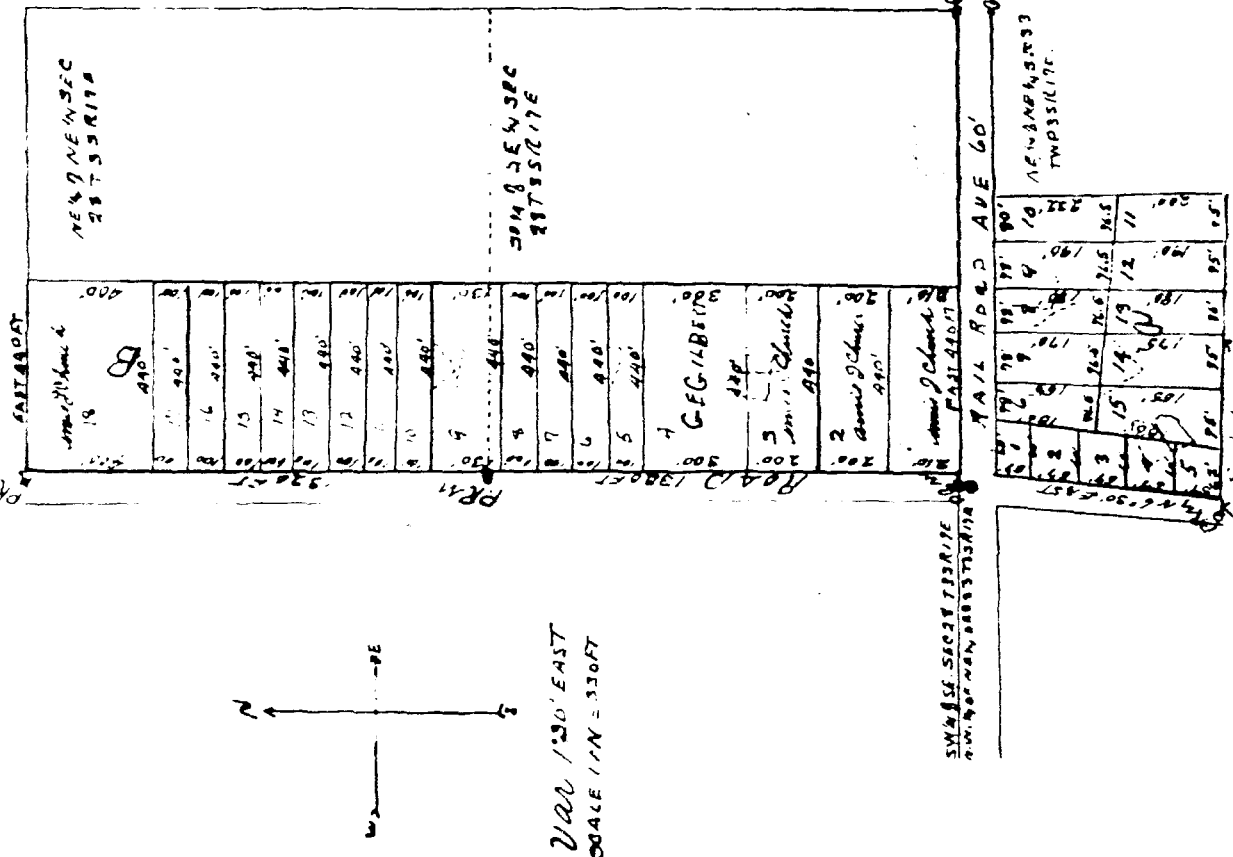


E. L. PATTERSON'S SUBDIVISION
