### HAMMOND'S ADDITION

A SUBDIVISION OF THE EAST (E 1/4) QUARTER OF THE WEST (W 1/2) HALF OF THE SW 1/4 OF THE NW 1/4, SECTION 33, TWS. 3-SOUTH, RANGE 17-EAST, COLUMBIA COUNTY, FLORIDA AS LIES BETWEEN ST. JOHNS AND PUTNAM STREETS.

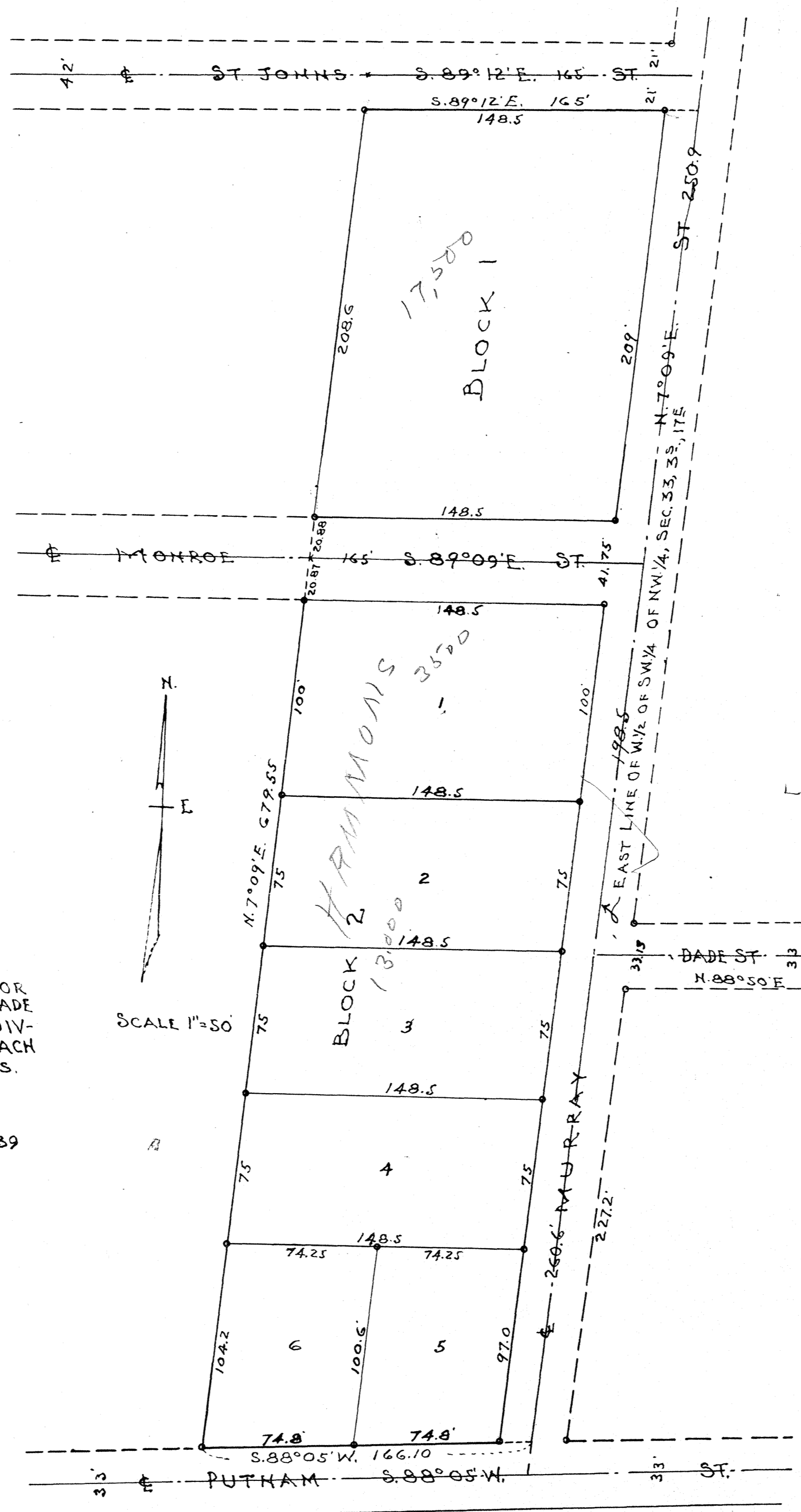
#### DESCRIPTION

BEGIN AT THE POINT OF INTERSECTION OF THE SOUTH LINE OF ST. JOHNS STREET AND THE EAST LINE OF THE W 1/2 OF THE SW 1/4 OF THE NW 1/4 OF SAID SECTION 33. (SAID POINT OF BEGINNING BEING ON THE WEST LINE OF ORIGINAL MURRAY AVE. OR STREET) AND RUN THENCE S. 7° 09' W., ALONG THE EAST LINE OF SAID W 1/2 OF THE SW 1/4 OF THE NW 1/4, 669 FEET, MORE OR LESS, TO THE NORTH LINE OF PUTNAM STREET, THENCE S. 88° 05' W., ALONG THE NORTH LINE OF PUTNAM STREET, 166.1 FEET; THENCE N. 7° 09' E., 679.55 FEET, MORE OR LESS, TO THE SOUTH LINE OF ST. JOHNS STREET, THENCE S. 89° 12' E., 165 FEET TO POINT OF BEGINNING.
