COMMENCE at the Southwest Corner of the Southeast 1/4 of Section 27, Township 3 South, Range 16 East, Columbia County, Florida and run S 89° 58' 58" E 25.02 feet to a point on the Southerly Right of Way Line of Center Street, also being the South line of said Section 27; thence N 1° 55' 02" W parallel with the West line of the S.E. 1/4 of said Section 27 a distance of 50.04 feet to a concrete P.R.M. and the POINT OF BEGINNING; thence N 1° 55' 02" W along same line, also being the East Right of Way Line of West Lake City Hills Avenue, 610.25 feet to a concrete P.R.M. on the North line of the South 1/2 of the S.W. 1/4 of the S.E. 1/4 of said Section 27; thence S 89° 41' 21" E along said North line 685.41 feet to a concrete P.R.M.; thence S 2° 10' 34" E parallel with the East line of the S.W. 1/4 of the S.W. 1/4 of the S.E. 1/4 of said Section 27 a distance of 610.85 feet to a concrete P.R.M. on the North Right of Way Line, Center Street; thence N 89° 38' 58" W along said North Right of Way Line, Center Street and parallel with the South line of said Section 27 a distance of 636.39 feet to the POINT OF BEGINNING.
