

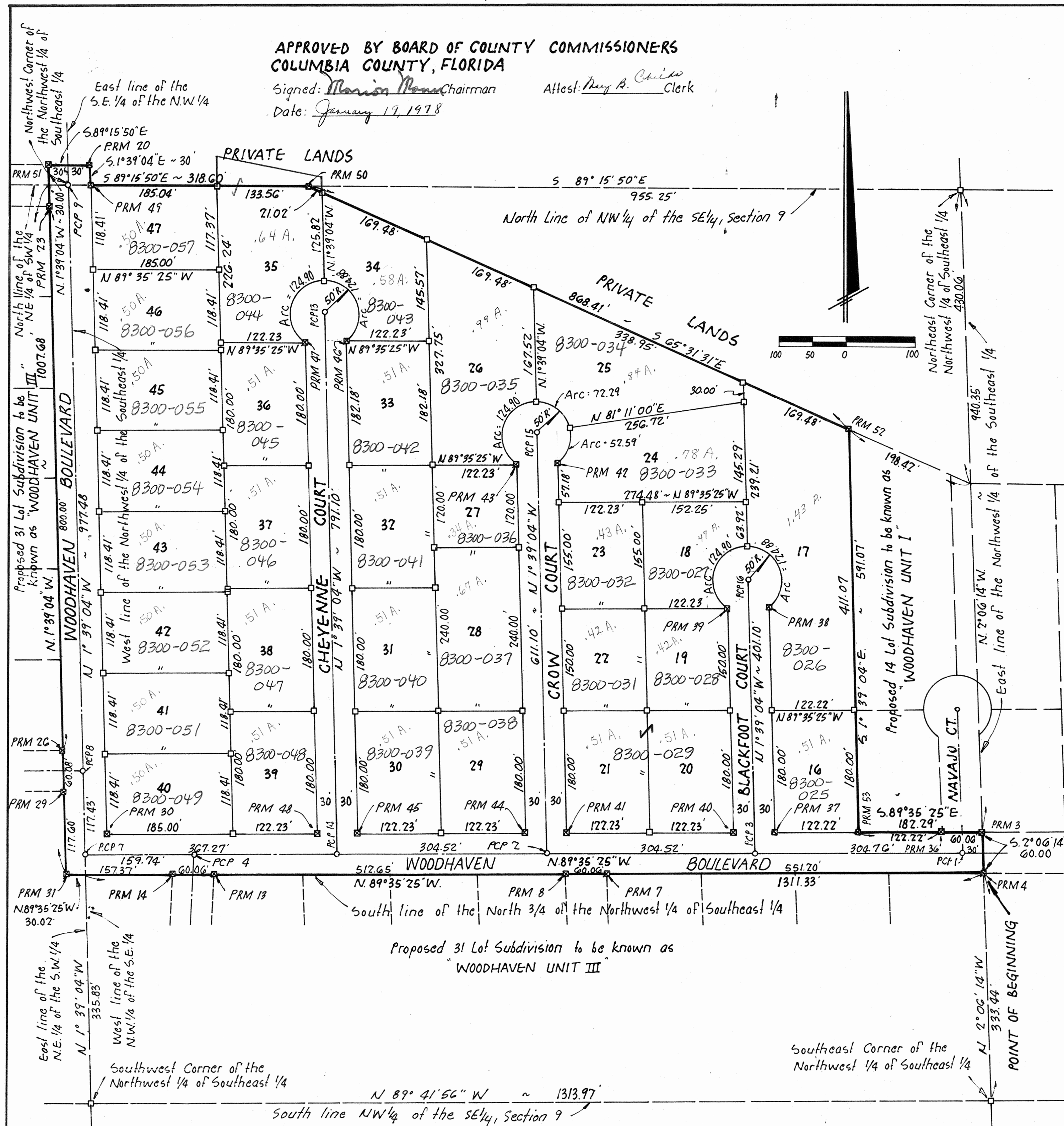

DESCRIPTION:

A Tract of land irregular in shape lying in parts of the NE 1/4 of the SW 1/4, the SE 1/4 of the NW 1/4, the SW 1/4 of the NE 1/4 and the NW 1/4 of the SE 1/4, Section 9, Township 4 South, Range 17 East, Columbia County, Florida being more particularly described as follows:
COMMENCE at the Southeast corner of the NW 1/4 of the SE 1/4 of said Section 9, Township 4 South, Range 17 East, Columbia County, Florida and run N. 2° 06' 14" W. along the East line of said NW 1/4 of the SE 1/4, a distance of 333.44 Feet to the Southeast Corner of the North 3/4 of the NW 1/4 of the SE 1/4 and the POINT OF BEGINNING; thence N. 89° 35' 25" W. along the South line of said North 3/4 of the NW 1/4 of the SE 1/4 a distance of 1311.33 Feet to the West line of said NW 1/4 of the SE 1/4, also being the East line of the NE 1/4 of the SW 1/4; thence continue N. 89° 35' 25" W. a distance of 30.02 Feet; thence N. 1° 39' 04" W. 1007.68 Feet to the North line of said NE 1/4 of the SW 1/4; thence continue N. 1° 39' 04" W. 30.00 Feet; thence S. 89° 15' 50" E. 30.00 Feet to the East line of the SE 1/4 of the NW 1/4; thence continue S. 89° 15' 50" E. 30.00 Feet; thence S. 1° 39' 04" E. 30.00 Feet to the North line of said NW 1/4 of the SE 1/4; thence S. 89° 15' 50" E. along said North line 318.60 Feet; thence S. 65° 31' 31" E. 868.41 Feet; thence S. 1° 39' 04" E. 591.07 feet; thence S. 89° 35' 25" E. 182.29 Feet to the East line of the NW 1/4 of the SE 1/4; thence S. 2° 06' 14" E. along said East line 60.00 Feet to said Southeast corner of the North 3/4 of the NW 1/4 of the SE 1/4 and the POINT OF BEGINNING. Containing 23.86 acres, more or less.
