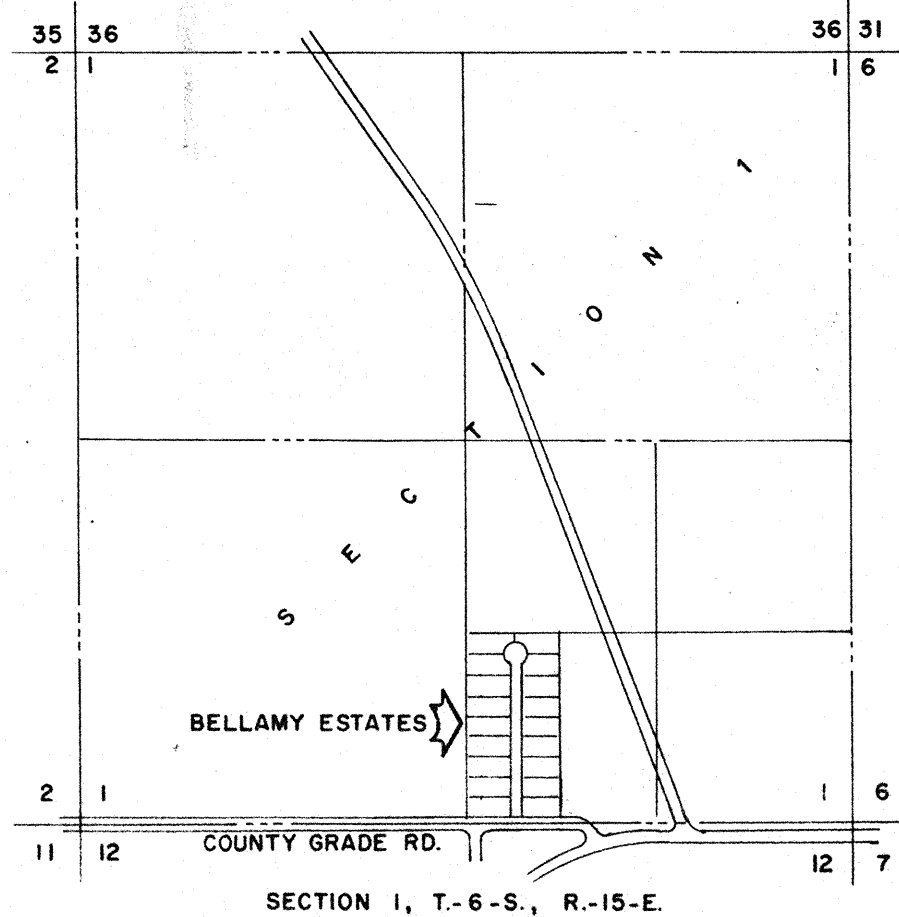
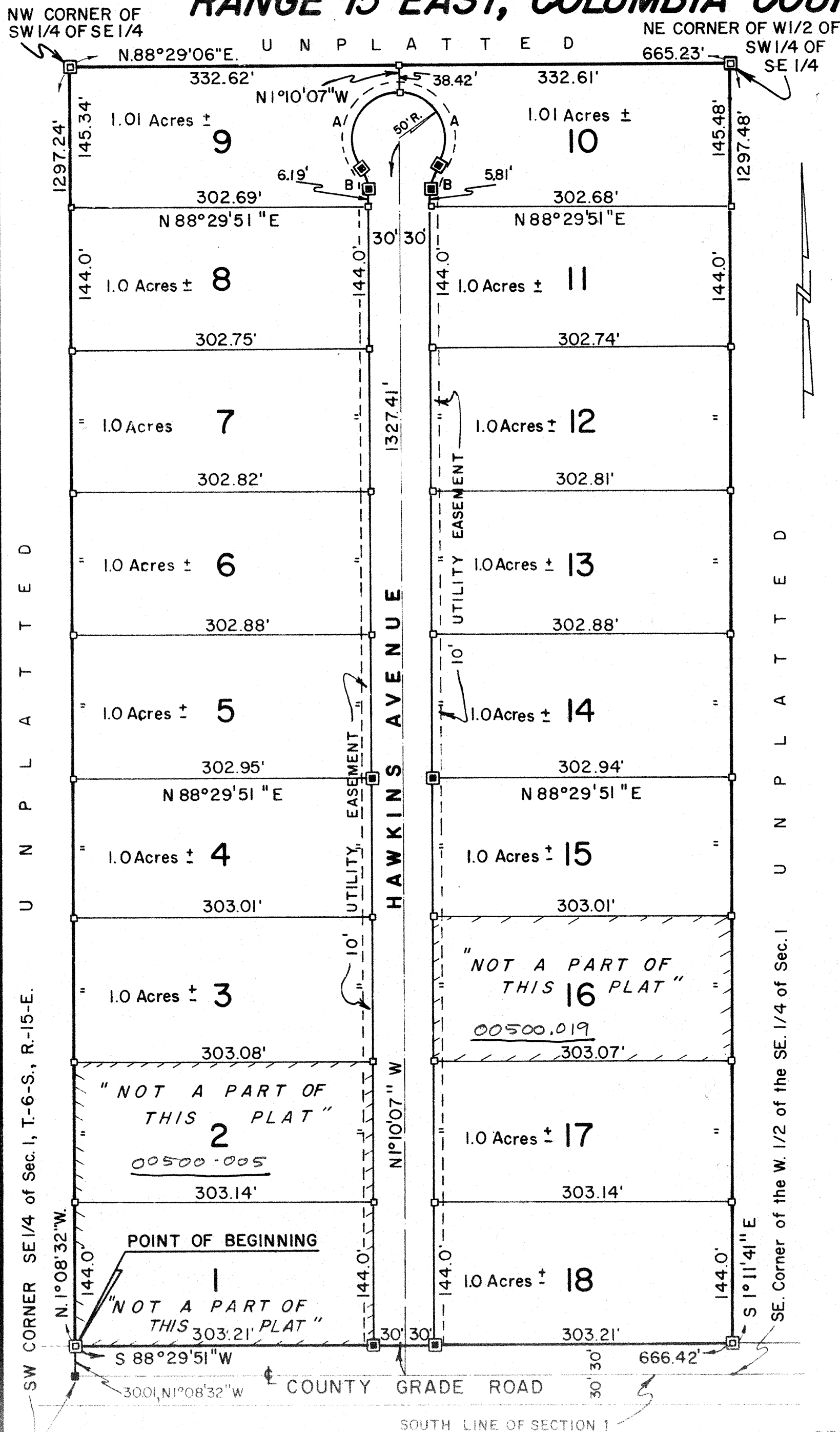

DESCRIPTION

A subdivision of the West 1/2 of the Southwest 1/4 of the Southeast 1/4 of Section 1, Township-6-South, Range-15-East, Columbia County, Florida, being more particularly described as follows: Commence at the Southwest corner of the Southeast 1/4 of said Section 1, Township-6-South, Range-15-East, and run thence N.1°08'32"W., 30.01' feet to a point on the North Right-of-Way Line of a county maintained graded road (a 60 foot right-of-way as now established) for a Point of Beginning; thence continue N.1°08'32"W., along the West boundary of the Southeast 1/4 of said Section 1, 1297.24 feet; thence N.88°29'06"E., along the North boundary of the Southwest 1/4 of the Southeast 1/4 of said Section 1, 665.23 feet; thence S.1°11'41"E. along the East boundary of the West 1/2 of the Southwest 1/4 of the Southeast 1/4 of said Section 1, 1297.48 feet to point on the aforementioned North right-of-way line of a county maintained graded road; thence S.88°29'51"W., along said right-of-way line 666.42 feet to the point of beginning. Containing 20.287 Acres More or Less.
