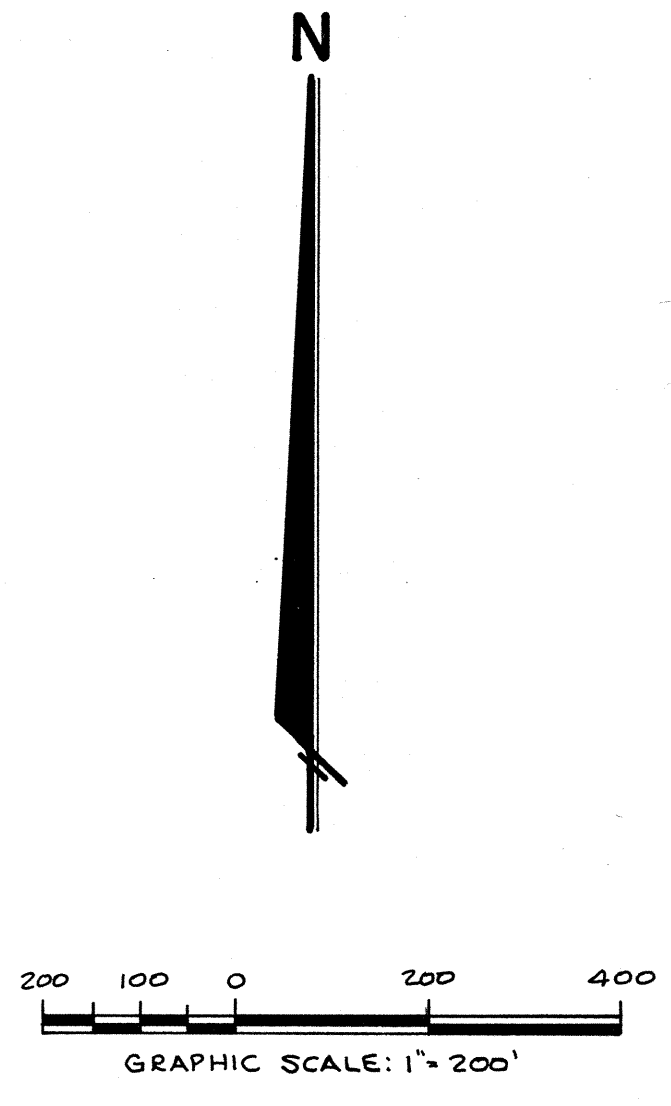
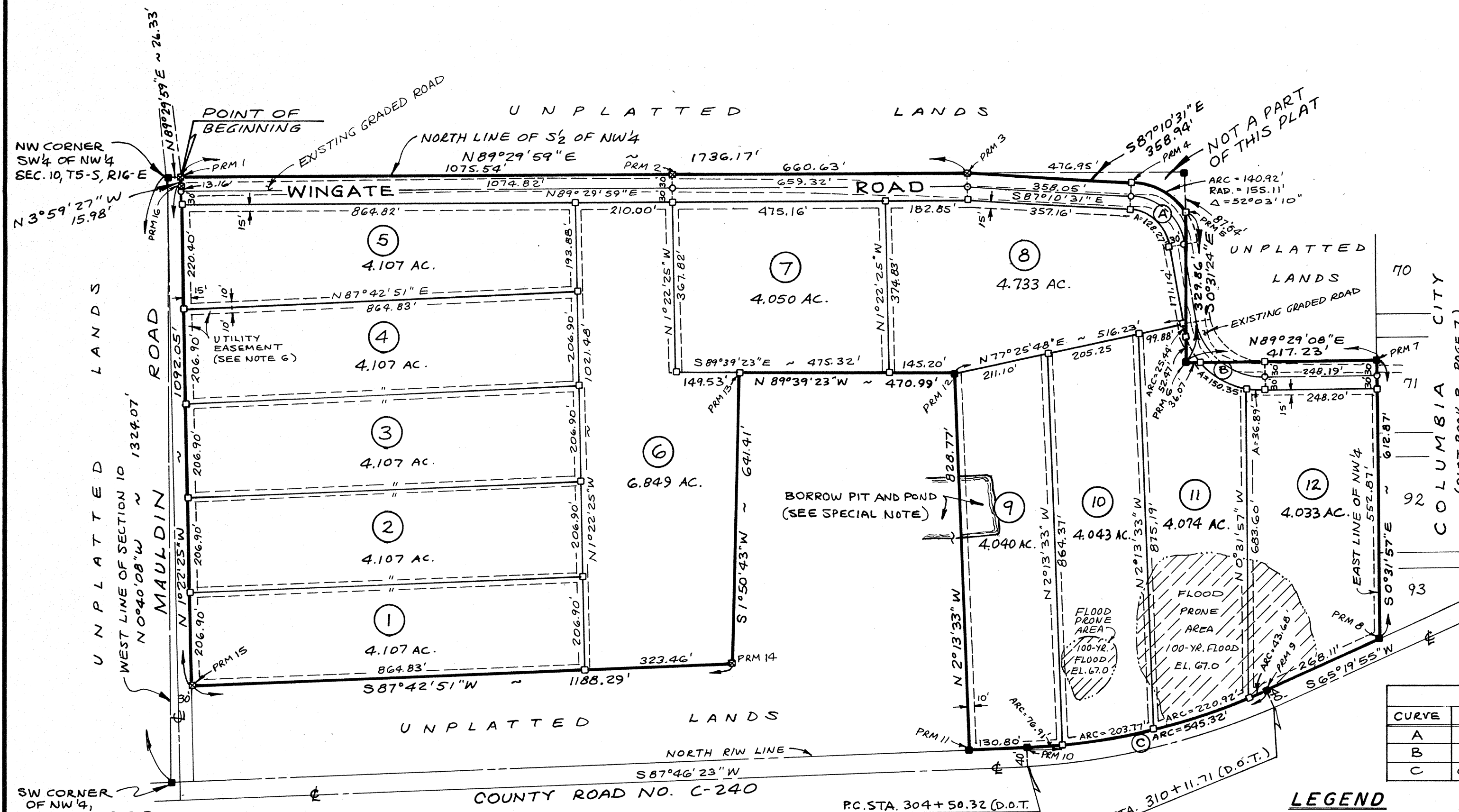

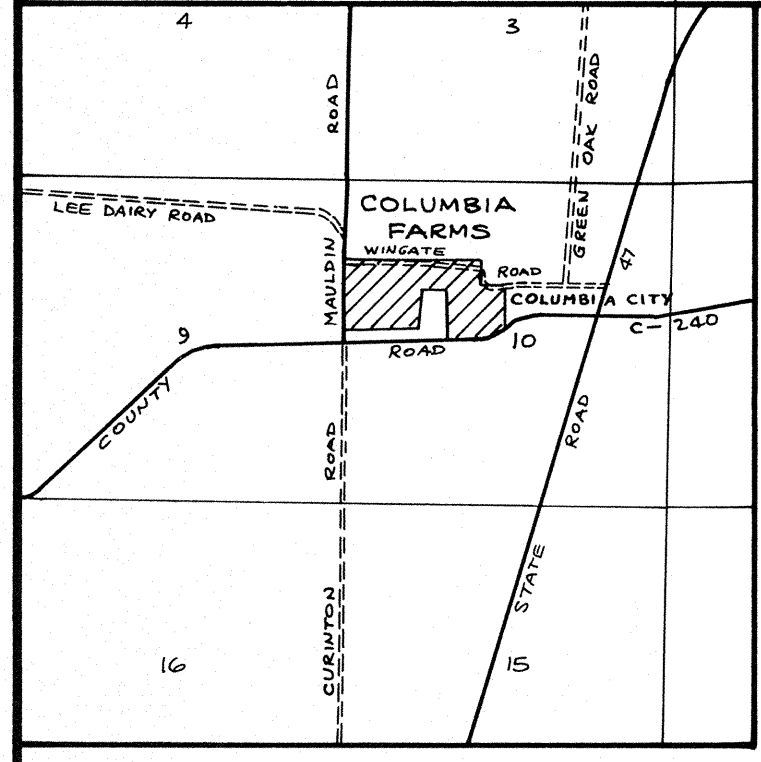

COMMENCE AT THE NORTHWEST CORNER OF THE SW 1/4 OF NW 1/4, SECTION 10, TOWNSHIP 5 SOUTH, RANGE 16 EAST, COLUMBIA COUNTY FLORIDA, AND RUN THENCE N 89°29'59"E ALONG THE NORTH LINE OF THE SW 1/4 OF NW 1/4, 26.33 FEET TO THE POINT OF BEGINNING, THENCE CONTINUE N 89°29'59"E ALONG THE NORTH LINE OF SAID SW 1/4 OF NW 1/4, 1736.17 FEET, THENCE S 87°10'31"E, 358.94 FEET TO A POINT OF CURVE, THENCE SOUTHEASTERLY ALONG SAID CURVE CONCAVE TO THE RIGHT HAVING A RADIUS OF 155.11 FEET AND A CENTRAL ANGLE OF 58°03'10", AN ARC DISTANCE OF 140.92 FEET, THENCE S 0°31'24"E, 329.86 FEET, THENCE N 89°29'08"E, 417.23 FEET TO THE EAST LINE OF SAID NW 1/4, THENCE S 0°31'57"E ALONG SAID EAST LINE, 612.87 FEET TO THE NORTH RIGHT-OF-WAY LINE OF COUNTY ROAD NO. C-240, THENCE S 65°19'55"W ALONG SAID NORTH RIGHT-OF-WAY LINE, 268.11 FEET TO THE P.T. OF A CURVE, THENCE WESTERLY ALONG SAID NORTH RIGHT-OF-WAY LINE ALONG A CURVE CONCAVE TO THE RIGHT HAVING A RADIUS OF 1392.39 FEET AND A CENTRAL ANGLE OF 22°26'22", AN ARC DISTANCE OF 545.32 FEET TO THE P.C.
