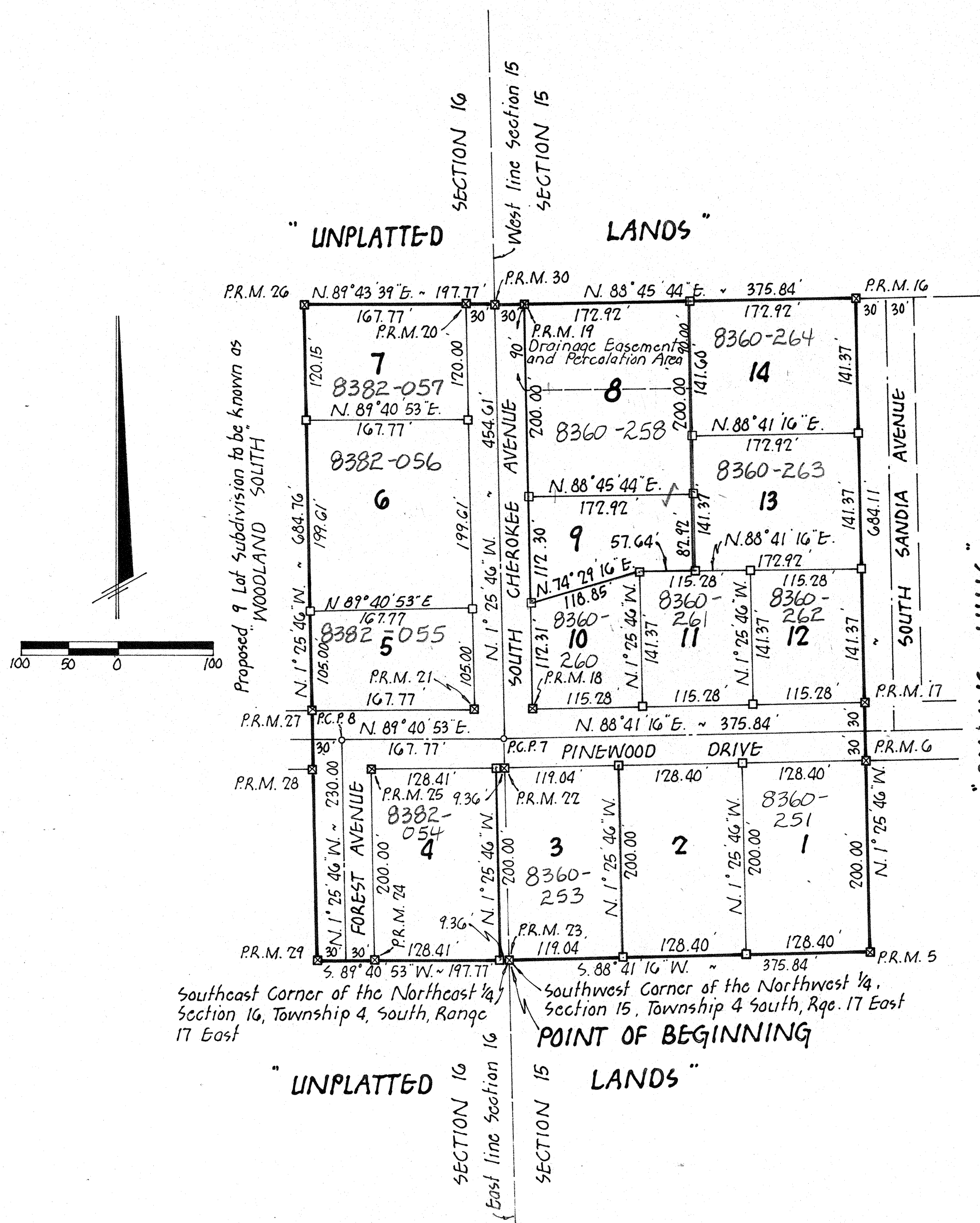

DESCRIPTION

The West 375.84 feet of the South 1/2 of the Southwest 1/4 of the Northwest 1/4, Section 15, Township 4 South, Range 17 East, Columbia County, Florida.

ALSO:

The East 197.77 feet of the South 1/2 of the Southeast 1/4 of the Northeast 1/4, Section 16, Township 4 South, Range 17 East, Columbia County, Florida being more particularly described as follows:
Begin at the Southeast Corner of the Northeast 1/4, Section 16, Township 4 South, Range 17 East, Columbia County, Florida (Southwest Corner of the Northwest 1/4, Section 15, Township 4 South, Range 17 East, Columbia County, Florida) and run S. 89° 40' 53" W. along the South line of said Northeast 1/4, Section 16 a distance of 197.77 feet; thence N. 1° 25' 46" W. 684.76 feet to the North line of the South 1/2 of the Southeast 1/4 of the Northeast 1/4, Section 16, thence N. 89° 43' 39" E. along said North line of the South 1/2 of the Southeast 1/4 of the Northeast 1/4, Section 16 a distance of 197.77 feet to the Northwest Corner of the South 1/2 of the Southwest 1/4 of the Northwest 1/4, Section 15; thence N. 88° 45' 44" E. along the North line of said South 1/2 of the Southwest 1/4 of the Northwest 1/4, Section 15 a distance of 375.84 feet; thence S. 1° 25' 46" E. 684.11 feet to the South line of said Northwest 1/4, Section 15; thence S. 88° 41' 16" W. along said South line 375.84 feet to the POINT OF BEGINNING. Containing 9.01 Acres more or less.

1. \square = 4"x4" Concrete Monument (Permanent Reference Monument) with brass cap in top stamped L.L. Lee and Associates, Inc. with surveyors registration number, date and monument number.
2. \square = 4"x4" Concrete Monument with brass cap in top stamped L.L. Lee and Associates, Inc. with surveyors registration number and date.
3. \circ = Permanent Control Point (P.C.P.) - 1/2" Iron Rod with cap stamped with P.C.P. Number and Surveyors registration number.
4. Bearings projected from State Road No. 5-133
