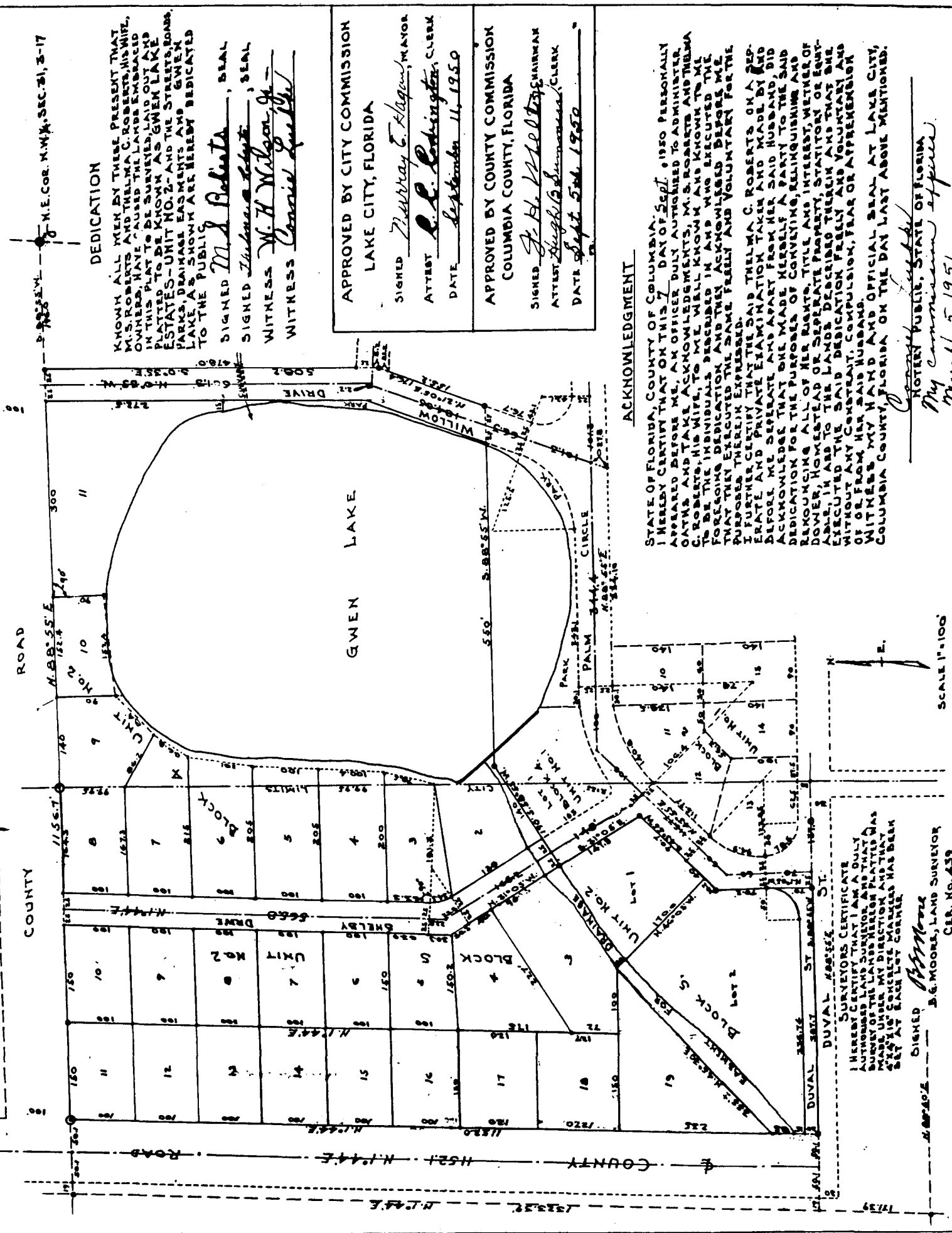


**GWEN LAKE ESTATE'S

COMMENCE AT THE N.E. COR. OF N.W. 1/4 OF SAID SECTION 31 AND RUN S. 88° 55' W. 196 FT. FOR A POINT OF BEGINNING AND RUN THENCE S. 0° 35' E. 308.2 FT. THENCE S. 21° 05' W. 116.4 FT. THENCE S. 88° 55' W. 550 FT. THENCE S. 88° 55' W. 190 FT. THENCE S. 31° 05' E. 141.9 FT. THENCE S. 48° 55' W. 160.9 FT. THENCE S. 1° 02' E. 140.2 FT. THENCE S. 80° 55' W. 387.7 FT. THENCE N. 1° 44' E. 115.2 FT. TO POINT OF BEGINNING.
