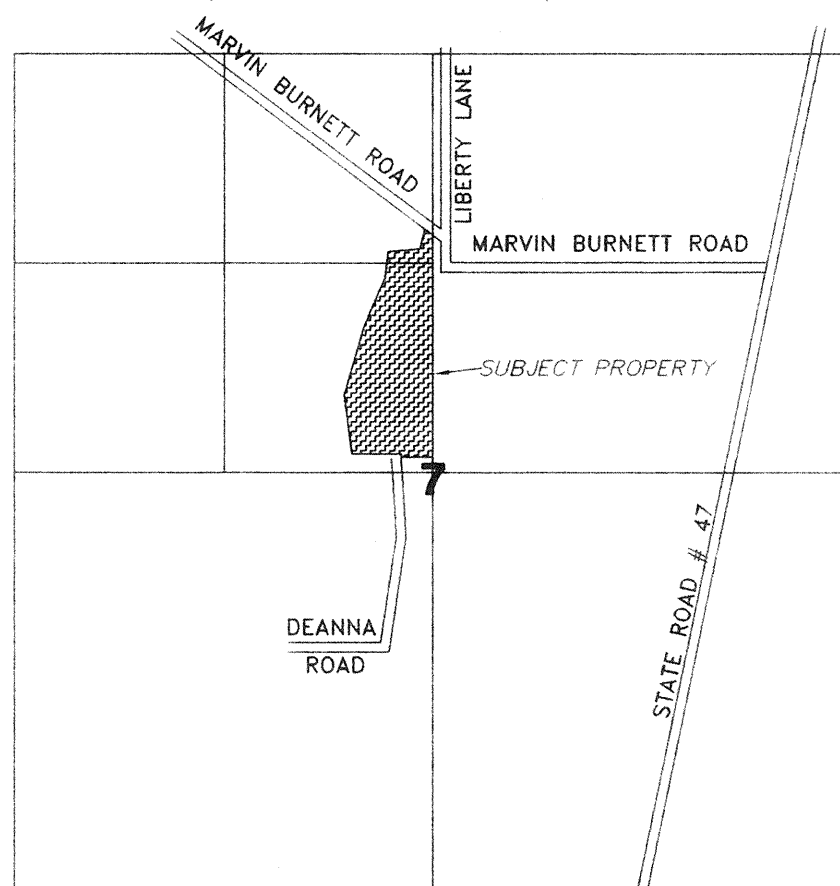

DESCRIPTION:

A PART OF THE EAST 1/2 OF THE NW 1/4 OF SECTION 7, TOWNSHIP 4 SOUTH, RANGE 17 EAST, MORE PARTICULARLY DESCRIBED AS FOLLOWS: BEGIN AT A CONCRETE MONUMENT MARKING THE NORTHWEST CORNER OF EDGEWOOD ESTATES BEING THEREON DEFINED AS THE NORTHEAST CORNER OF THE SE 1/4 OF SAID NW 1/4 AND RUN THENCE S.00°42'33"E., ALONG THE WEST LINE OF SAID EDGEWOOD ESTATES, A DISTANCE OF 1269.94 FEET; THENCE S.84°36'03"W., A DISTANCE OF 191.02 FEET TO A POINT ON THE EAST RIGHT-OF-WAY LINE OF DEANNA ROAD, SAID POINT BEING THE POINT OF CURVATURE OF A CURVE TO THE LEFT HAVING A RADIUS OF 630.0 FEET AND A CENTRAL ANGLE OF 25°23'32"; THENCE NORTHWESTERLY ALONG THE ARC OF SAID CURVE AN ARC DISTANCE OF 279.20 FEET; THENCE N.30°47'29"W., STILL ALONG SAID EAST RIGHT-OF-WAY LINE A DISTANCE OF 133.06 FEET TO THE POINT OF CURVATURE OF A CURVE TO THE RIGHT HAVING A RADIUS OF 200.0 FEET AND A CENTRAL ANGLE OF 54°15'32"; THENCE NORTHEASTERLY ALONG THE ARC OF SAID CURVE AN ARC DISTANCE OF 189.40 FEET; THENCE N.23°28'08"E., STILL ALONG SAID EAST RIGHT-OF-WAY LINE, A DISTANCE OF 400.78 FEET TO THE POINT OF CURVATURE OF A CURVE TO THE LEFT, HAVING A RADIUS OF 630.0 FEET, A CENTRAL ANGLE OF 17°11'11"; THENCE NORTHEASTERLY ALONG THE ARC OF SAID CURVE, AN ARC LENGTH OF 188.97 FEET; THENCE N.06°16'57"E., STILL ALONG SAID RIGHT-OF-WAY LINE, A DISTANCE OF 223.77 FEET; THENCE N.02°26'31"E., A DISTANCE OF 245.60 FEET TO ITS INTERSECTION WITH THE SOUTHERLY RIGHT-OF-WAY LINE OF BURNETT ROAD; THENCE S.53°11'33"E., ALONG SAID SOUTHERLY RIGHT-OF-WAY LINE, A DISTANCE OF 40.47 FEET TO ITS INTERSECTION WITH THE WEST RIGHT-OF-WAY LINE OF A COUNTY PAVED ROAD; THENCE S.02°08'13"E., ALONG SAID RIGHT-OF-WAY, A DISTANCE OF 122.41 FEET TO THE POINT OF CURVATURE OF A CURVE TO THE LEFT, HAVING A RADIUS OF 165.00 FEET, A CENTRAL ANGLE OF 48°31'03"; THENCE SOUTHEASTERLY ALONG THE ARC OF SAID CURVE, AN ARC LENGTH OF 139.72 FEET; THENCE S.00°42'33"E., A DISTANCE OF 21.12 FEET TO THE POINT OF BEGINNING. ALSO COMMENCE AT THE SE CORNER OF THE NW 1/4 OF SAID SECTION 7; THENCE N.00°42'33"W., A DISTANCE OF 56.40 FEET; THENCE S.84°36'03"W., A DISTANCE OF 251.02 FEET TO THE WEST RIGHT-OF-WAY OF DEANNA ROAD; SAID POINT BEING A POINT OF CURVE OF A CURVE CONCAVE TO THE WEST, HAVING A RADIUS OF 570.0 FEET, AN INCLUDED ANGLE OF 0°45'09"; THENCE NORTHERLY ALONG THE ARC OF SAID CURVE AN ARC DISTANCE OF 7.49 FEET TO THE NORTHEAST CORNER OF LOT 1, BLOCK B OF "HOLLY BROOK" AS PER PLAT RECORDS OF COLUMBIA COUNTY, FLORIDA AND THE POINT OF BEGINNING OF THE LAND HEREIN DESCRIBED; THENCE S.84°36'03"W., ALONG THE NORTH LINE OF SAID LOT 1 AND ITS PROJECTION A DISTANCE OF 348.17 FEET; THENCE N.08°41'05"W., A DISTANCE OF 372.95 FEET; THENCE N.20°30'00"E., A DISTANCE OF 378.33 FEET; THENCE N.18°30'00"E., A DISTANCE OF 407.92 FEET; THENCE N.09°30'03"E., A DISTANCE OF 250.86 FEET; THENCE S.76°15'32"E., A DISTANCE OF 51.18 FEET TO A POINT OF CURVE OF A CURVE TO THE LEFT, HAVING A RADIUS OF 260.00 FEET, A CENTRAL ANGLE OF 11°15'57"; THENCE EASTERLY ALONG THE ARC OF SAID CURVE, AN ARC LENGTH OF 51.27 FEET; THENCE S.87°33'29"E., A DISTANCE OF 36.30 FEET TO THE POINT OF CURVATURE OF A CURVE TO THE RIGHT, HAVING A RADIUS OF 25.00 FEET, A CENTRAL ANGLE OF 93°50'28"; THENCE SOUTHEASTERLY ALONG THE ARC OF SAID CURVE, AN ARC LENGTH OF 40.95 FEET, TO ITS INTERSECTION WITH THE WEST RIGHT-OF-WAY LINE OF SAID DEANNA ROAD; THENCE S.08°16'57"W., ALONG SAID WEST RIGHT-OF-WAY LINE, A DISTANCE OF 162.97 FEET TO THE POINT OF CURVATURE OF A CURVE TO THE RIGHT, HAVING A RADIUS OF 570.0 FEET, A CENTRAL ANGLE OF 17°11'11"; THENCE SOUTHWESTERLY ALONG THE ARC OF SAID CURVE, AN ARC LENGTH OF 170.98 FEET; THENCE S.23°28'08"W., STILL ALONG SAID WEST RIGHT-OF-WAY LINE, A DISTANCE OF 400.78 FEET TO THE POINT OF CURVATURE OF A CURVE TO THE LEFT, HAVING A RADIUS OF 260.00 FEET, A CENTRAL ANGLE OF 54°15'32"; THENCE SOUTHEASTERLY ALONG THE ARC OF SAID CURVE, AN ARC LENGTH OF 246.22 FEET; THENCE S.30°47'29"E., STILL ALONG SAID WEST RIGHT-OF-WAY LINE, A DISTANCE OF 133.06 FEET TO THE POINT OF CURVATURE OF A CURVE TO THE RIGHT, HAVING A RADIUS OF 570.00 FEET, A CENTRAL ANGLE OF 24°38'17"; THENCE SOUTHEASTERLY ALONG THE ARC OF SAID CURVE, AN ARC LENGTH OF 245.11 FEET TO THE END OF SAID CURVE; TO THE POINT OF BEGINNING COLUMBIA COUNTY, FLORIDA. CONTAINING 13.9 ACRES MORE OR LESS.

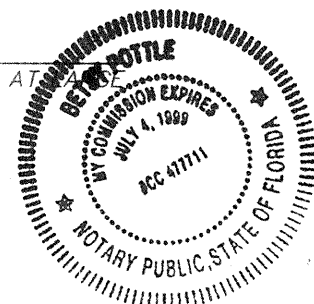

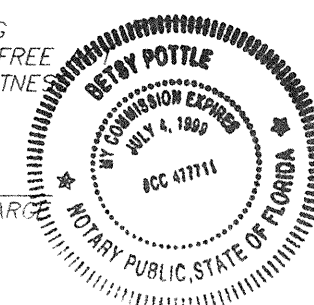
