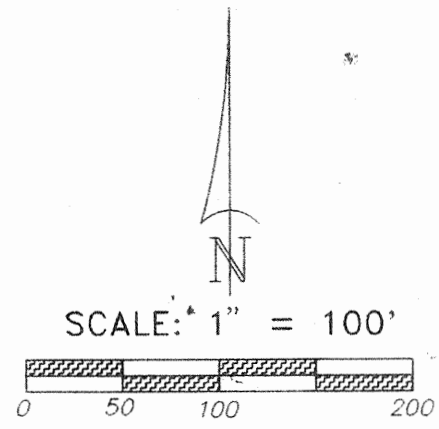

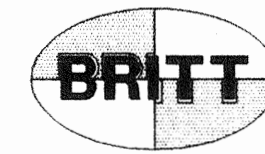

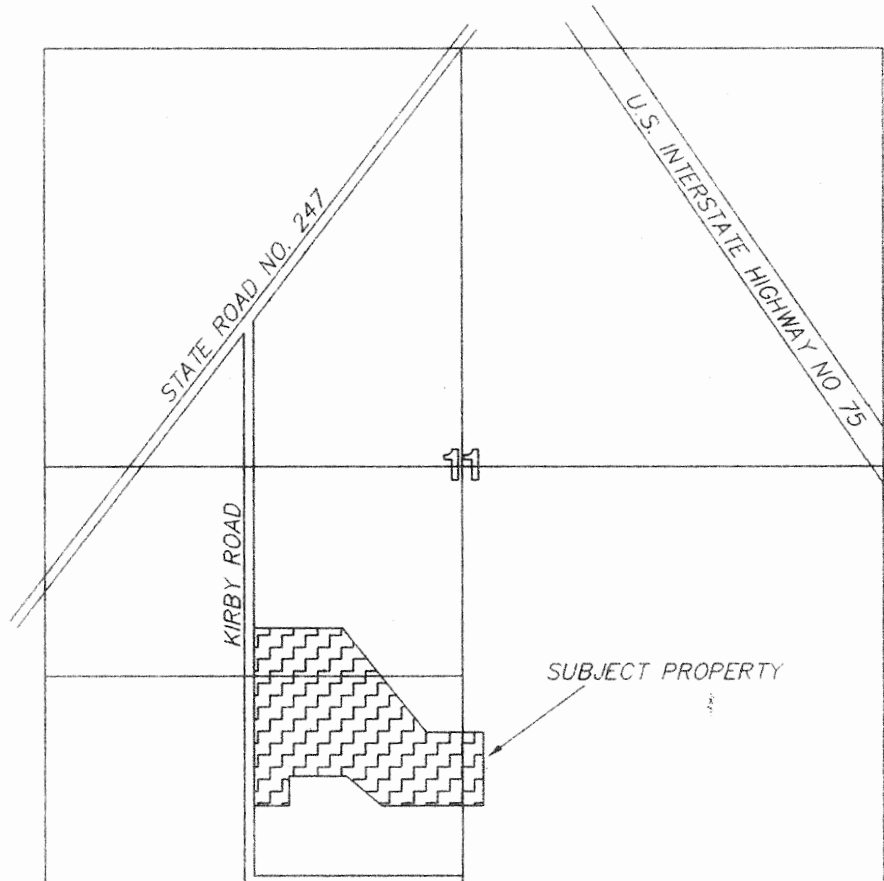

3. BEARINGS ARE BASED ON AN ASSUMED DATUM. THE SOUTH LINE OF SECTION 11, TOWNSHIP 4 SOUTH, RANGE 16 EAST, HELD AS S.87°34'50"W.
4. SOME PORTIONS OF THIS PARCEL ARE IN ZONE "A" AND MAY BE SUBJECT TO FLOODING. HOWEVER, A FLOOD ELEVATION OF 123.00 FEET HAS BEEN DETERMINED FOR ZONE "A".
