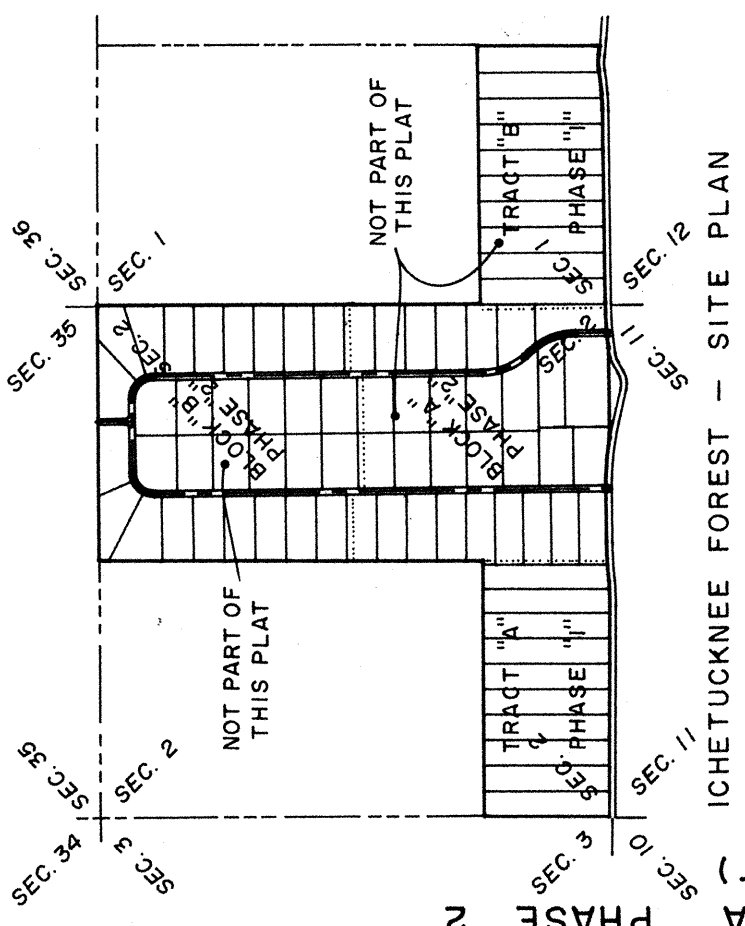
EAST LINE OF THE SOUTHWEST 1/4 OF SECTION 2
