A SUBDIVISION IN THE SOUTHEAST $\frac{1}{4}$ OF THE
SOUTHWEST $\frac{1}{4}$ OF SECTION 35, TOWNSHIP 3-SOUTH,
RANGE 15-EAST, COLUMBIA COUNTY, FLA.

DESCRIPTION

A PART OF THE SOUTHEAST $\frac{1}{4}$ OF THE SOUTHWEST $\frac{1}{4}$ OF SECTION 35, TOWNSHIP 3-SOUTH, RANGE 15-EAST, MORE PARTICULARLY DESCRIBED AS FOLLOWS: COMMENCE AT THE SOUTHWEST CORNER OF THE SOUTHEAST $\frac{1}{4}$ OF THE SOUTHWEST $\frac{1}{4}$ OF SECTION 35 AND RUN N. 88° 16' 00" E. ALONG THE SOUTH LINE OF SAID SECTION 35, 42.57 FEET TO THE EAST RIGHT-OF-WAY LINE OF STATE ROAD NO. 252-A FOR A POINT OF BEGINNING. THENCE NORTHERLY ALONG THE ARC OF A CURVE TO THE RIGHT HAVING A RADIUS OF 2824.79 FEET, AN INCLUDED ANGLE OF 3° 27' 02", FOR AN ARC DISTANCE OF 170.12 FEET, TO THE PT. OF SAID CURVE; THENCE N. 140° 12' W. ALONG SAID RIGHT-OF-WAY LINE, 439.72 FEET TO THE PC OF A CURVE TO THE RIGHT HAVING A RADIUS OF 2824.79 FEET, AN INCLUDED ANGLE OF 6° 40' 56" THENCE ALONG THE ARC OF SAID CURVE FOR AN ARC DISTANCE OF 329.42 FEET; THENCE N. 88° 10' 54" E., 404.92 FEET; THENCE S. 048° 40' E., 447.11 FEET; THENCE S. 88° 16' 00" W. PARALLEL WITH THE SOUTH LINE OF SAID SECTION 35, 417.38 FEET, TO THE EAST RIGHT-OF-WAY LINE, 60.0 FEET; THENCE N. 88° 16' 00" E. PARALLEL TO SAID SOUTH LINE OF SECTION 35, 416.48 FEET; THENCE S. 140° 26' E., 432.0 FEET TO THE SOUTH LINE OF SAID SECTION 35; THENCE S. 38° 16' 00" W. ALONG SAID SOUTH LINE OF SECTION 35, 404.85 FEET TO THE POINT OF BEGINNING. COLUMBIA COUNTY, FLA., CONTAINING 8.33 ACRES MORE OR LESS.
