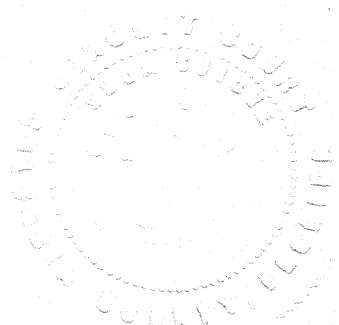

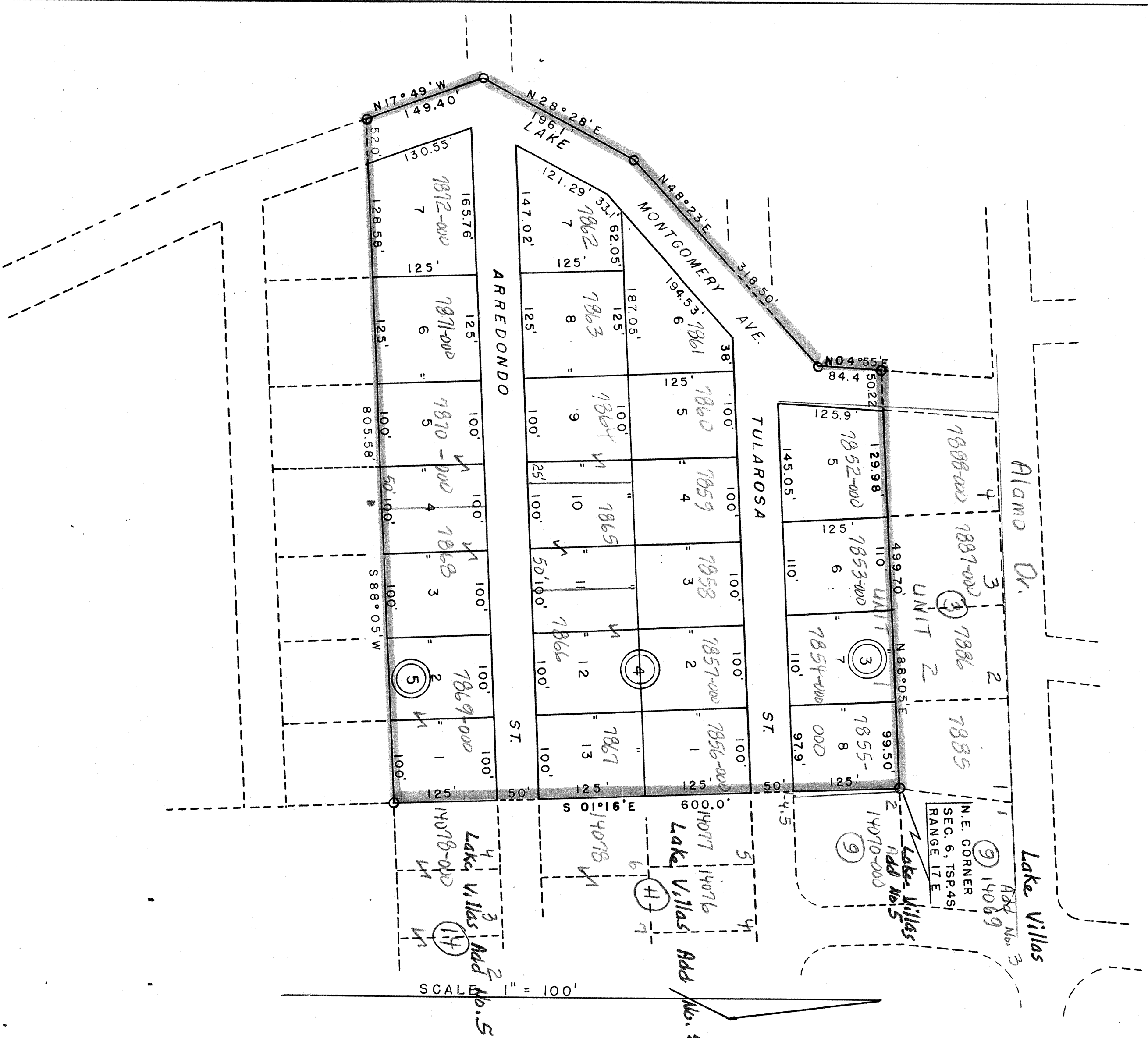

 BEGIN AT THE N.E. CORNER OF SEC. 6, TSP. 4 S, R17E AND RUN THENCE S 01° 16' E ALONG EAST LINE OF SAID SEC. 6, 600.0 FEET, THENCE RUN N 88° 05' W, PARALLEL TO THE NORTH LINE OF SAID SEC. 6, 805.58 FEET, THENCE RUN N 17° 49' W, 149.40 FEET, THENCE RUN N 28° 28' E, 196.1 FEET, THENCE RUN N 48° 23' E, 318.50 FEET, THENCE RUN N 04° 35' E, 84.40 FEET TO THE NORTH LINE OF SAID SEC. 6, THENCE RUN N 88° 05' E ALONG SAID NORTH LINE, 499.70 FEET TO THE POINT OF BEGINNING.
