## DESCRIPTION

ONE SQUARE ACRE IN BLOCK 297 OF THE EASTERN DIVISION OF THE CITY OF LAKE CITY, FLORIDA, BOUNDED WEST BY LOT SOLD TO O. O. WEBB, TAN. 18, 1923 AND RECORDED IN DEED BOOK 12, PAGE 119, RECORDS OF COLUMBIA COUNTY, FLORIDA; SAID LANDS BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: BEGIN AT THE NORTHWEST CORNER OF "VILLA HEIGHTS" A SUBDIVISION OF A PART OF BLOCK 297 AND 298 OF THE EASTERN DIVISION, LAKE CITY, FLORIDA, ACCORDING TO PLAT OF SAID "VILLA HEIGHTS" ON FILE IN THE OFFICE OF THE CLERK OF THE CIRCUIT COURT, COLUMBIA COUNTY, FLORIDA IN PLAT BOOK 2, PAGE 9 AND RUN SOUTHERLY ALONG THE WEST LINE OF SAID "VILLA HEIGHTS" 206.3 FEET TO MONROE STREET; THENCE WEST ALONG MONROE STREET, 190.5 FEET; THENCE NORTH 205 FEET TO ST.
