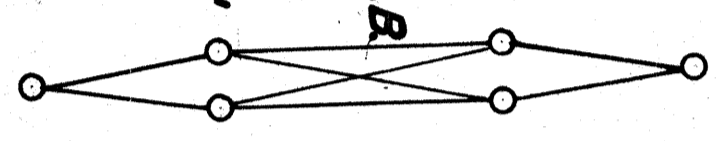

DESCRIPTION:
COMMENCE AT THE SE CORNER OF THE N.E. 1/4 OF S.W. 1/4 OF SEC. 33 T.3S R.1E AND RUN N 89° 14' 35" E ALONG THE SOUTH LINE OF SAID N.E. 1/4 OF S.W. 1/4 OF SEC. 33 T.3S R.1E 81.57' TO THE EAST R/W OF CHERRY DRIVE EXTENDED 277.75' TO THE SOUTH R/W OF BAYA AVE. RUN THENCE SOUTHEASTERLY ALONG THE S/D EXTENDED RUN THENCE S 8° 27' 35" W ALONG SAID WEST R/W 81.57' TO THE SOUTH LINE OF SAID N.E. 1/4 OF S.W. 1/4 OF SEC. 33 T.3S R.1E 419.24' TO THE P.O.B. WESTERLY ALONG SAID R/W 419.24' TO THE P.O.B.



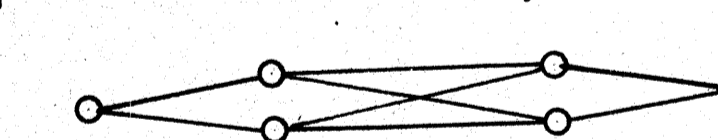
DEDICATION
