



**DESCRIPTION**

COMMENCE AT THE NORTHWEST CORNER OF THE SW<sup>1</sup>/<sub>4</sub>, SECTION 27, TOWNSHIP 2 SOUTH, RANGE 16 EAST, COLUMBIA COUNTY, FLORIDA AND RUN THENCE N 88° 22' 37" E ALONG THE NORTH LINE OF SAID SW<sup>1</sup>/<sub>4</sub>, 1319.51 FEET, THENCE S 27° 54' 18" E, 791.02 FEET TO THE POINT OF BEGINNING, THENCE CONTINUE S 27° 54' 18" E, 1328.26 FEET TO THE NORTH RIGHT-OF-WAY LINE OF FIDDLER'S WAY, THENCE N 58° 15' 17" E ALONG SAID NORTH RIGHT-OF-WAY LINE, 730.60 FEET TO A POINT OF CURVATURE OF A CURVE CONCAVE TO THE LEFT HAVING A RADIUS OF 25.00 FEET AND AN INCLUDED ANGLE OF 90° 00', THENCE NORTHWESTERLY ALONG THE ARC OF SAID CURVE, 39.27 FEET TO THE WESTERLY RIGHT-OF-WAY LINE OF STATE ROAD NO. 25 (U.S. HIGHWAY 41), THENCE N 31° 44' 43" W ALONG SAID WESTERLY RIGHT-OF-WAY LINE, 397.50 FEET TO THE P.C. OF A CURVE, THENCE NORTHWESTERLY ALONG SAID CURVE CONCAVE TO THE RIGHT HAVING A RADIUS OF 5853.578 FEET ALONG A CHORD BEARING N 27° 18' 32" W, 905.49 FEET, THENCE S 58° 15' 17" W, 736.68 FEET TO THE POINT OF BEGINNING.


