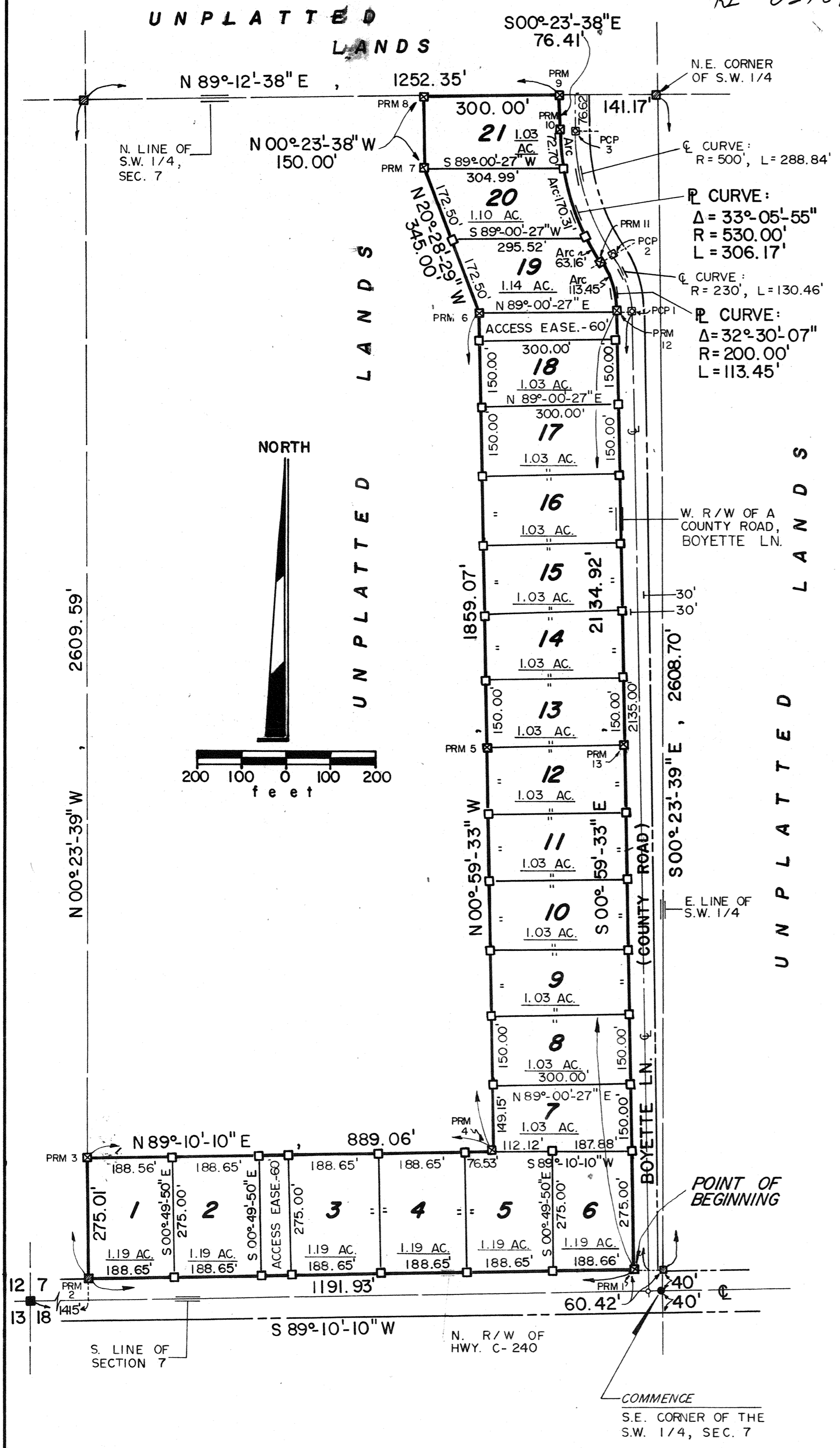

# SOUTH COLUMBIA ACRES

PART OF THE S.W. 1/4 OF SECTION 7, TOWNSHIP 5 SOUTH, RANGE 16 EAST COLUMBIA COUNTY, FLORIDA



### DESCRIPTION

COMMENCE at the Southeast Corner of the Southwest 1/4 of Section 7, Township 5 South, Range 16 East, Columbia County, Florida and run N.00°23'39"W., along the East Line of Said Southwest 1/4 a distance of 40.00 feet to a point on the Northerly Right-of-Way line of Highway C-240; thence S.89°10'10"W., along Said Northerly Right-of-Way Line 60.42 feet to a point on the Westerly Right-of-Way Line of a County Road and the POINT OF BEGINNING; thence continue S.89°10'10"W., still along Said Northerly Right-of-Way Line of Highway C-240, a distance of 1191.93 feet; thence N.00°23'39"W., 275.01 feet; thence N.89°10'10"E., 889.06 feet; thence N.00°59'33"W., 1859.07 feet; thence N.20°28'29"W., 345.00 feet; thence N.00°23'38"W., 150.00 feet to a point on the North Line of Said Southwest 1/4 of Section 7; thence N.89°12'38"E., along Said North Line, 300.00 feet to a point on the Westerly Right-of-Way Line of Said County Road; thence S.00°23'38"E., along Said Westerly Right-of-Way Line, 76.41 feet to the Point of Curve of a curve concave to the Northeast having a Radius of 530.00 feet and a Central Angle of 33°05'55", Said curve also having a Chord Bearing of S.16°56'36"E. and a Chord Distance of 301.93 feet; thence, Southerly, along the arc of Said curve (also Said Westerly Right-of-Way Line), 306.17 feet to the Point of Compound Curve of a curve concave to the Southwest having a Radius of 200.00 feet and a Central Angle of 32°30'07", Said curve also having a Chord Bearing of S.17°14'37"E. and a Chord Distance of 111.94 feet; thence, Southerly, along the arc of Said Curve (also Said Westerly Right-of-Way Line), 113.45 feet to the Point of Tangency of Said curve; thence S.00°59'33"E., still along Said Westerly Right-of-Way Line, 2134.92 feet to the POINT OF BEGINNING. Containing 23.60 acres, more or less.
