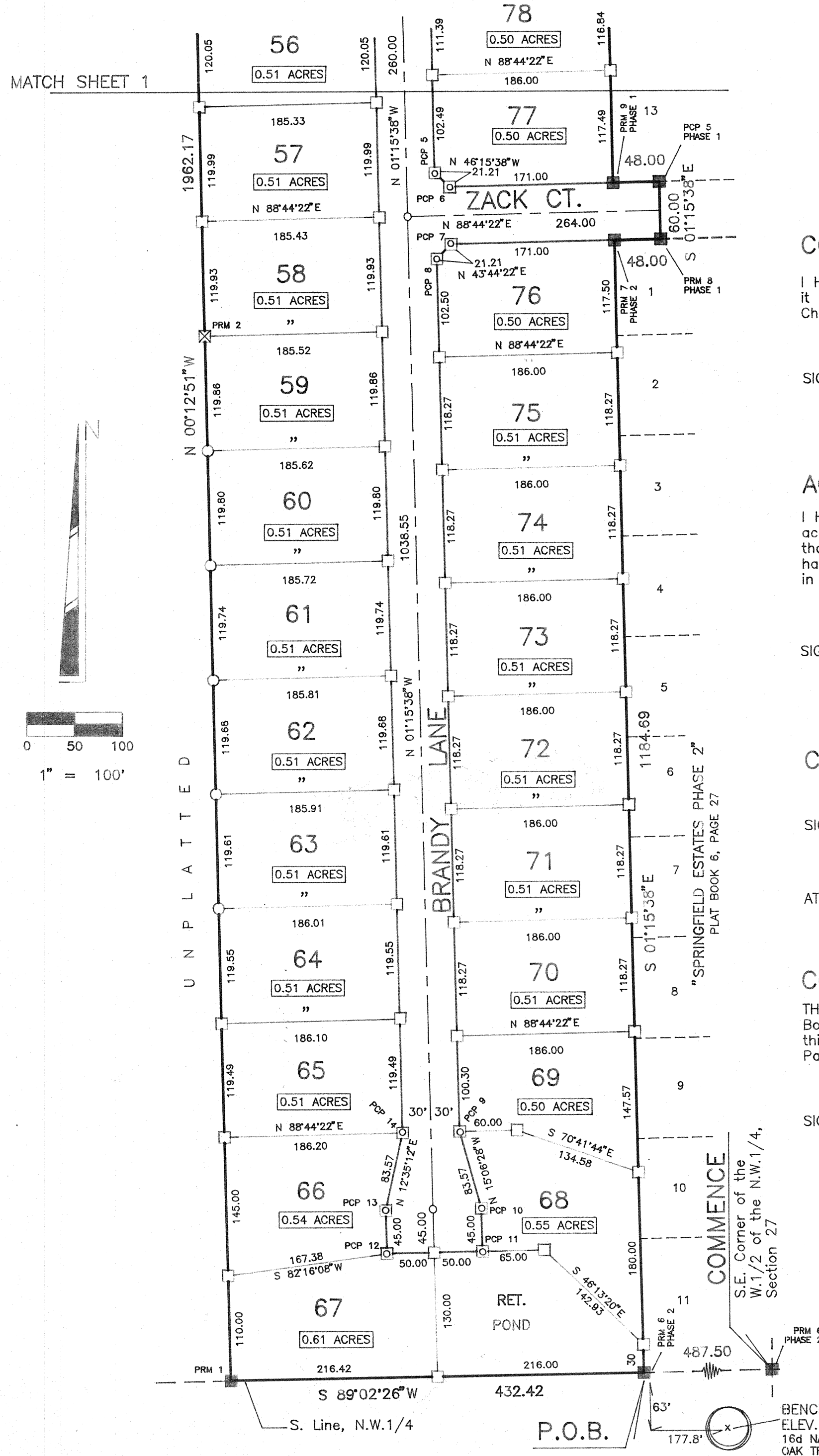

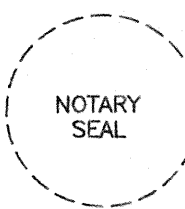

DESCRIPTION

COMMENCE at the Southeast corner of the West 1/2 of the Northwest 1/4 of Section 27, Township 4 South, Range 16 East, Columbia County, Florida and run S.89°02'26"W. along the South line of said Northwest 1/4 a distance of 487.50 feet to the POINT OF BEGINNING; thence continue S.89°02'26"W. still along said South line 432.42 feet; thence N.01°12'51"W. 1962.17 feet; thence S.89°05'19"E. 69.05 feet to the Southeast corner of a parcel of land described in O.R. Book 573, Page 449; thence N.01°13'03"W. along the East line of said parcel of land 632.43 feet to a point on the Southerly Right-of-Way line of County Road No. 242; thence S.88°34'34"E. along said Southerly Right-of-Way line 71.10 feet to the Point of Curve of a curve concave to the North having a radius of 7679.44 feet and a central angle of 02°10'01"; thence Easterly along the arc of said curve, being also said Southerly Right-of-Way line 290.45 feet to the Northwest corner of REPLAT OF SPRINGFIELD ESTATES PHASE 1, as recorded in Plat Book 6, Page 7; thence S.01°15'38"E. along the West line of said REPLAT OF SPRINGFIELD ESTATES PHASE 1 a distance of 1338.13 feet; thence N.88°44'22"E. along the South line of said REPLAT OF SPRINGFIELD ESTATES PHASE 1 a distance of 48.00 feet; thence S.01°15'38"E. 60.00 feet to a point on the North line of SPRINGFIELD ESTATES PHASE 2, as recorded in Plat Book 6, Page 27; thence S.88°44'22"W. along said North line 48.00 feet; thence S.01°15'38"E. along the West line of said SPRINGFIELD ESTATES PHASE 2 a distance of 1184.69 feet to the POINT OF BEGINNING. Containing 24.69 acres, more or less.
