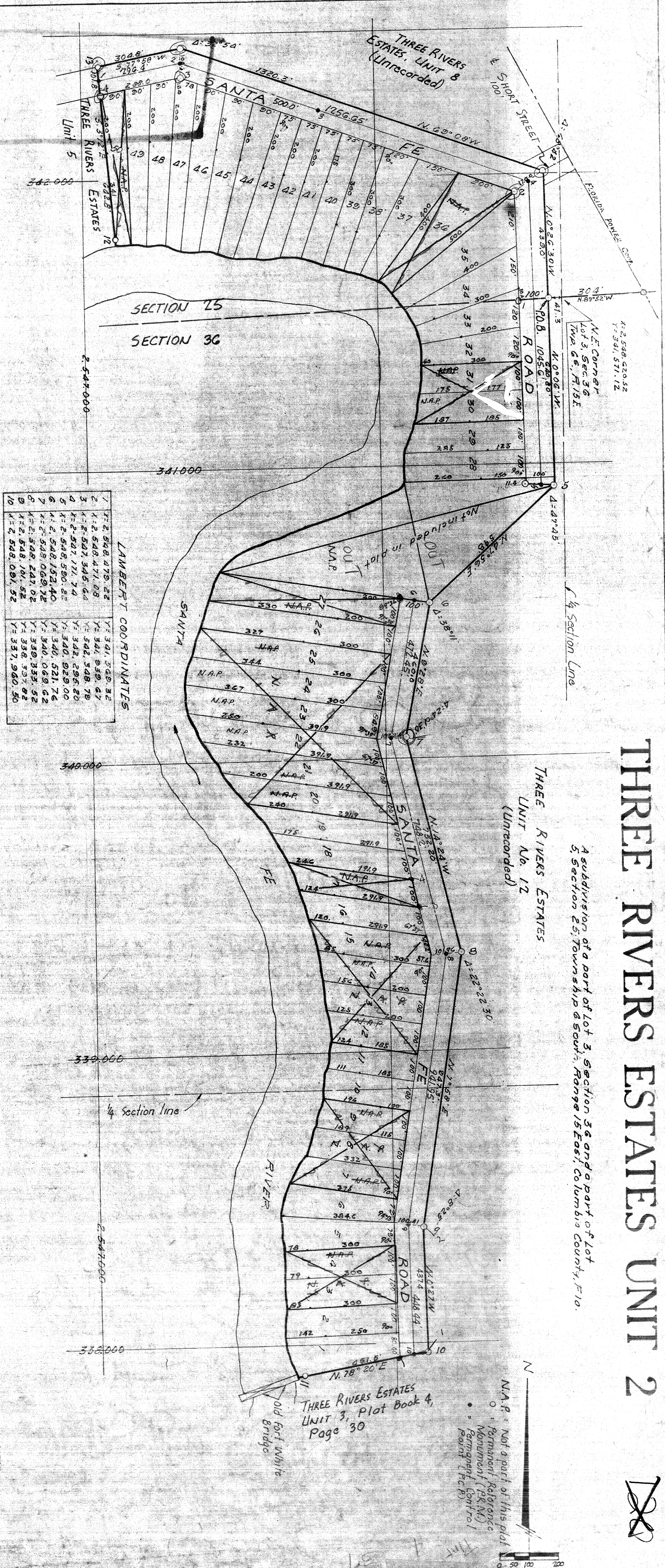


THREE RIVERS ESTATES UNIT 2

DESCRIPTION

Commence at the northeast corner of said lot 3, Section 36 and run North 88 degrees 52 minutes West 41.3 feet to a point of beginning and run thence North 49 degrees 06 minutes West 1320.3 feet, thence South 3 degrees 12 minutes East 642.8 feet, more or less to the shore line of the Santa Fe River, thence South easterly along said shore line to the center of the east end of Old Fort White bridge, thence North 78 degrees 20 minutes East 151.5 feet, thence North 10 degrees 27 minutes West 151.4 feet, thence North 71 degrees 59 minutes East 241.3 feet, thence North 10 degrees 27 minutes West 28 minutes East 160.0 feet, thence North 49 degrees 06 minutes East 598.0 feet, thence North 10 degrees 27 minutes West 440.0 feet to point of beginning.
