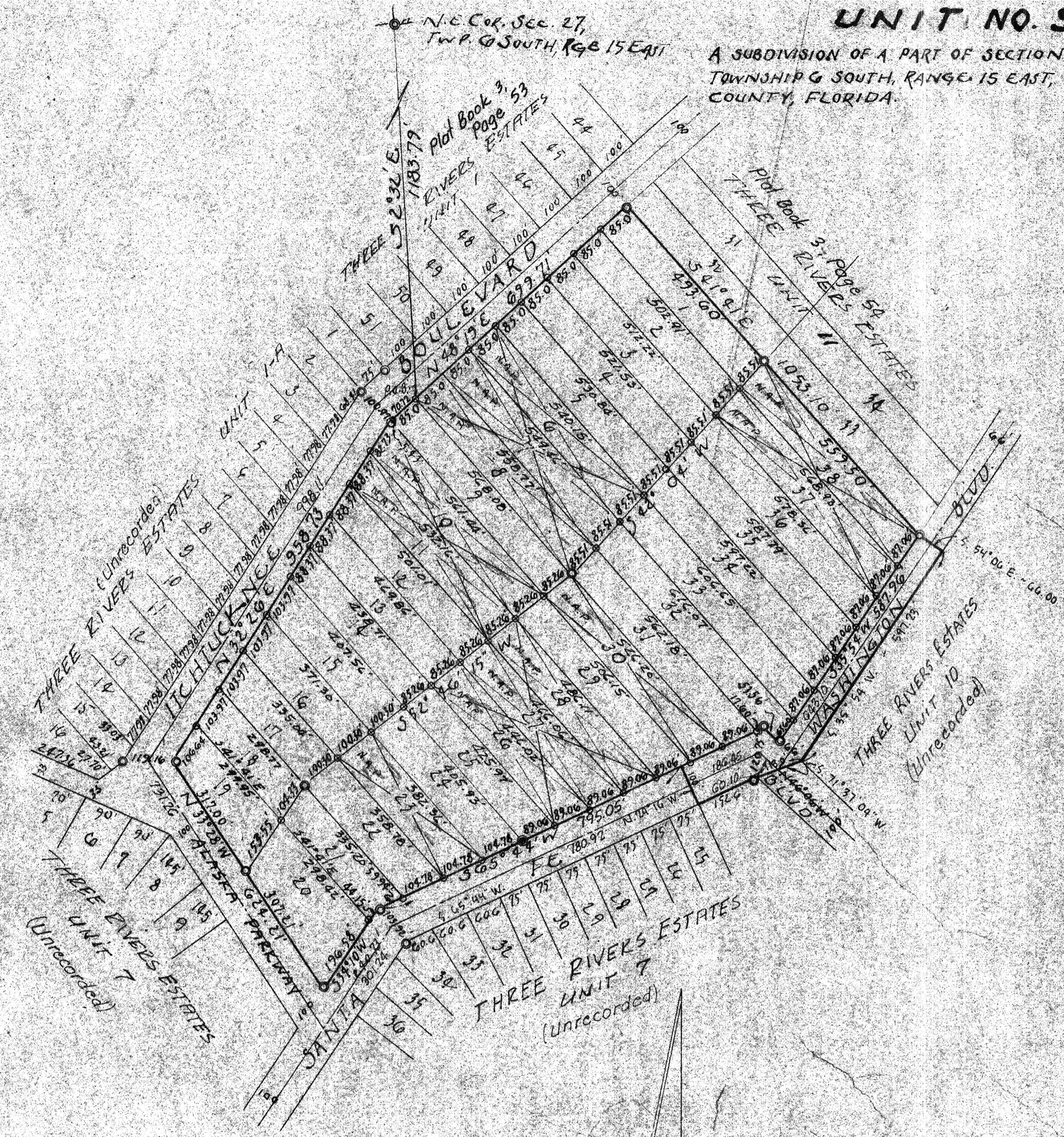


**THREE RIVERS ESTATES

DESCRIPTION

COMMENCE AT THE NORTHEAST CORNER OF SECTION 27, TOWNSHIP 6 SOUTH, RANGE 15 EAST, COLUMBIA COUNTY, FLORIDA AND RUN S. 2° 32' E. 1183.79 FEET FOR A POINT OF BEGINNING; THENCE N. 48° 19' E. 699.71 FEET; THENCE S. 41° 41' E. 1053.10 FEET; THENCE S. 44° 06' E. 66.00 FEET; THENCE S. 35° 54' W. 597.23 FEET; THENCE S. 71° 37' 04" W. 113.00 FEET; THENCE S. 65° 44' W. 152.60 FEET; THENCE N. 24° 16' W. 100.00 FEET; THENCE S. 65° 44' W. 745.05 FEET; THENCE S. 34° 10' W. 240.73 FEET; THENCE N. 33° 28' W. 624.21 FEET; THENCE N. 32° 26' E. 958.73 FEET; THENCE N. 48° 19' E. 70.72 FEET TO THE POINT OF BEGINNING.
