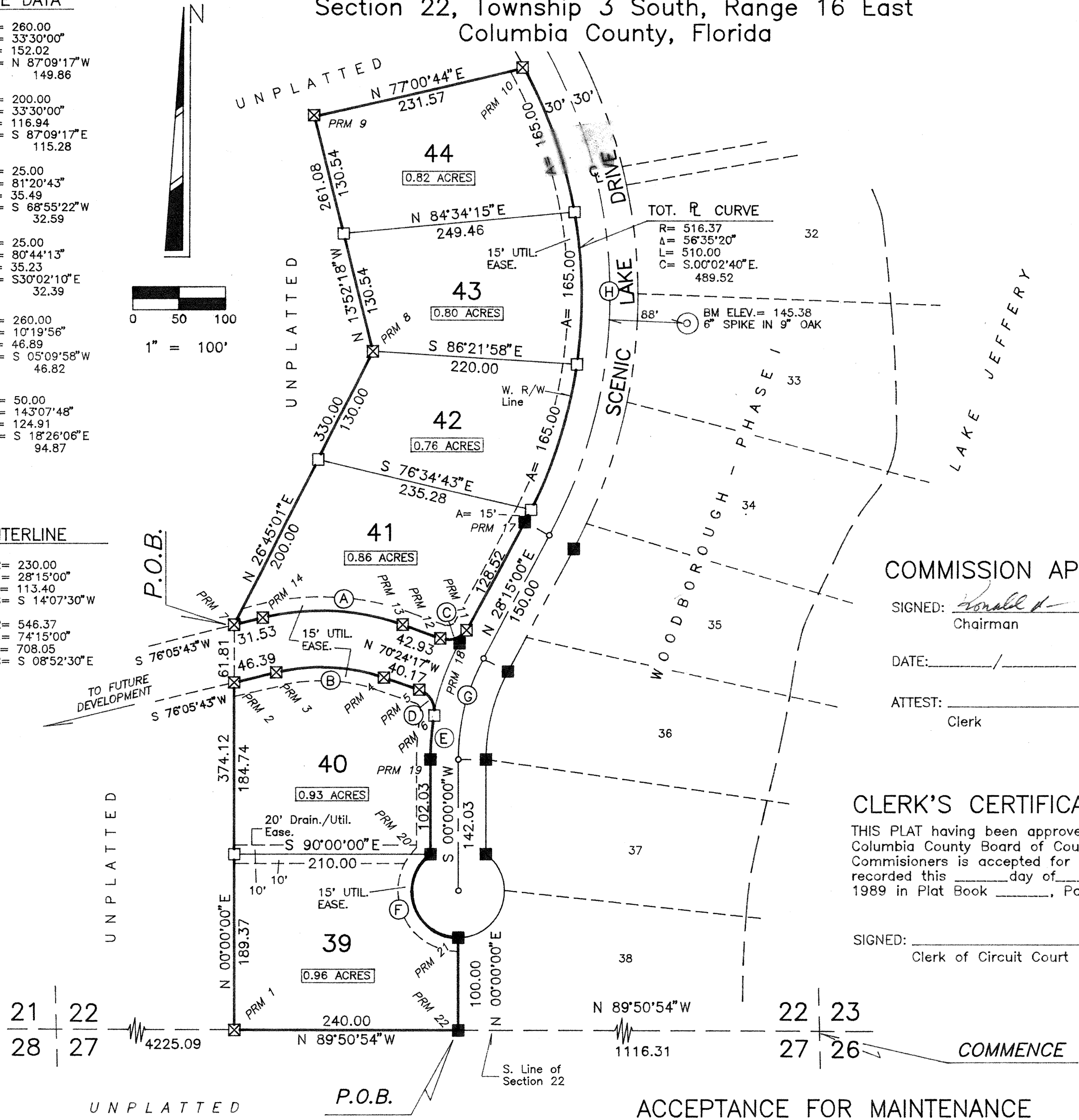

DESCRIPTION

COMMENCE at the Southeast corner of Section 22, Township 3 South, Range 16 East, Columbia County, Florida and run N.89°50'54"W. along the South Line of said Section 22 a distance of 1116.31 feet to the POINT OF BEGINNING; thence continue N.89°50'54"W. still along said South line 240.00 feet; thence North 374.12 feet to a point designated as "PRM No. 2"; thence run N.76°05'43"E. 46.39 feet to the Point of Curve of a curve concave to the South having a radius of 200.00 feet and a central angle of 33°30'; thence Easterly along the arc of said curve 116.94 feet to the Point of Tangency of said curve; thence S.70°24'17"E. 40.17 feet to the Point of Curve of a curve concave to the Southwest having a radius of 25.00 feet and a central angle of 80°44'13"; thence Southeasterly along the arc of said curve 35.23 feet to the Point of Reverse Curve of a curve concave to the East having a radius of 260.00 feet and a central angle of 10°19'56"; thence Southerly along the arc of said curve, being also the Westerly Right-of-Way line of Scenic Lake Drive 46.89 feet; thence South, still along said Westerly Right-of-Way line 102.03 feet to a point on the arc of a curve concave to the East having a radius of 50.00 feet and a central angle of 143°07'48"; thence Southerly along the arc of said curve, being also said Westerly Right-of-Way line of Scenic Lake Drive 124.91 feet; thence South 100.00 feet to the POINT OF BEGINNING.

AND ALSO: COMMENCE at hereinabove referenced "PRM No. 2" and run North 61.81 feet to the POINT OF BEGINNING; thence N.26°45'01"E. 330.00 feet; thence N.13°52'18"W. 261.08 feet; thence N.77°00'44"E. 231.57 feet to a point on the Westerly Right-of-Way line of Scenic Lake Drive, said point being on the arc of a curve concave to the West having a radius of 516.37 feet and a central angle of 56°35'20"; thence Southerly along the arc of said curve, being also said Westerly Right-of-Way line 510.00 feet to the Point of Tangency of said curve; thence S.28°15'00"W. still along said Westerly Right-of-Way line 128.52 feet to the Point of Curve of a curve concave to the Northwest having a radius of 25.00 feet and a central angle of 81°20'43"; thence Southwesterly along the arc of said curve 35.49 feet to the Point of Tangency of said curve; thence N.70°24'17"W. 42.93 feet to the Point of Curve of a curve concave to the South having a radius of 260.00 feet and a central angle of 33°30'00"; thence West-erly along the arc of said curve 152.02 feet to the Point of Tangency of said curve; thence S.76°05'43"W. 31.53 feet to the POINT OF BEGINNING.
